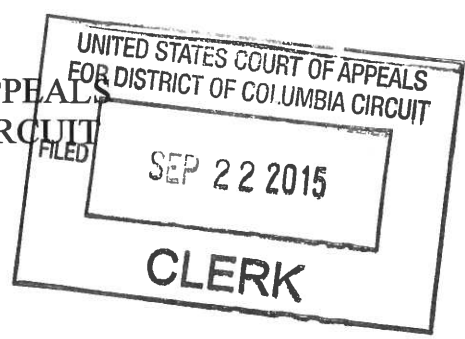

**PETITION FOR REVIEW**

The United States Postal Service petitions this Court for review of Postal Regulatory Commission (“PRC” or “Commission”) Order Number 2686, *Order Denying Transfer of First-Class Mail Parcels to the Competitive Product Category*, in PRC Docket Number MC2015-7. In Order Number 2686, the Commission denied the Postal Service’s request under 39 U.S.C. § 3642 to transfer a postal product, First-Class Mail Parcels, from the list of market-dominant products to the list of competitive products. Market-dominant products are generally subject to a more stringent set of regulations than are competitive products.

Commission's online docket that same day, which constitutes service of the Order under the Commission's rules. *See* 39 C.F.R. § 3001.12(c). This Petition for Review is timely under 39 U.S.C. § 3663 because it was filed within 30 days after the Order was issued. This Court has jurisdiction to review an order of the Commission, and venue is proper in this Circuit. 39 U.S.C. § 3663.
